## Proposal Requirements

#### **Proposal Submission**

- Proposals should be mailed or hand-delivered
- Submit one (1) original and five (5) copies in addition to one (1) electronic document of the proposal with all required information.
- Any proposal received after the time and date specified will be disqualified and returned unopened
- The official closing time will be determined by the time clock located in the CCBH Administrative Office – mail area

# Proposal Requirements Cont'd.

#### **Proposal Submission**

- Vendors assume the risk of the method of dispatch chosen
- CCBH assumes no responsibility for delays caused by any delivery service
- Postmarking by the due date will not substitute for actual proposal receipt
- Proposals may NOT be delivered by facsimile transmission, email or other telecommunication or electronic means.

- Non-Collusion Affidavit with signature and must be notarized (Refer to Appendix 1)

# Advancing Regional Health Improvement and Health Equity Program

- Includes two main components:
  - Healthy Northeast Ohio website
  - Collaborative Cuyahoga County Community Health Needs
     Assessment (CHNA) and Community Health Improvement Plan
     (CHIP)/Implementation Strategy (IS) efforts
- Currently funded by a three-year grant (2022-2024) from the HealthComp Foundation and contributions from partnered local hospitals and public health departments
- Grant is led via a partnership between the Cuyahoga County Board of Health (direct awardee and fiscal agent) and The Center for Health Affairs (project management)

# Advancing Regional Health Improvement and Health Equity Program


- Sustaining healthyneo.org and the collaborative CHNA/CHIP efforts beyond the current grant funding cycle is a top priority to ensure longterm impact
- The Cuyahoga County Board of Health will apply for additional grant funding from the HealthComp Foundation in early 2023, for the specific purpose of engaging a sustainability consultant
- This RFP is contingent upon the Cuyahoga County Board of Health being awarded these additional grant funds from the HealthComp Foundation

# Healthy Northeast Ohio (www.healthyneo.org)

Healthy Northeast Ohio is a publicly available online resource for regional population health data in Northeast Ohio that launched in December 2019.

The website provides users with access to 300+ health and quality of life indicators, and other tools and resources to support local health improvement activities.

Healthy Northeast Ohio is utilized by the community and partners for grant applications, reports, publications, presentations, policy and program planning, and CHNA and CHIP/IS processes.



# Collaborative Cuyahoga County CHNA & CHIP/IS Efforts

The collaborative Cuyahoga County CHNA and CHIP/IS processes are jointly conducted every three years by hospitals and public health departments within Cuyahoga County.

The CHNA process involves systematic, comprehensive data collection and analysis about the community's current health status and issues, including direct community input, to identify current community health needs.

The CHIP/IS process uses data from the CHNA to identify priority issues, develop goals, and plan and implement health improvement strategies to address identified needs.



## Request for Proposals

- On November 8, 2022, CCBH released a competitive RFP to identify a sustainability consultant to develop and implement plans to sustain the Healthy Northeast Ohio website and the collaborative Cuyahoga County CHNA and CHIP/IS efforts
- Applications due December 6, 2022 by 10:30am to CCBH

# Program Period and Award Amounts

- Total amount available is up to \$50,000.00. Projects with total costs below \$50,000 are preferred.
- The project period for this application will begin on 6/1/2023 and will be up to 12 months in length.
- The total award amount and funding period length will be determined by the funder (HealthComp Foundation).

## Program Deliverables

#### The Sustainability Consultant will:

- Develop a sustainability plan focused on revenue generation strategies
- Develop new partnership and funding structure documents
- Develop value proposition language and related documents
- Work with program staff to implement the sustainability plan/revenue generation strategies
- Assist program staff with tracking implementation efforts

## Program Requirements

- Implementation of the Sustainability Plan/ Revenue Generation Strategies must begin no later than November 1, 2023
- Consultant will:
  - Participate in calls and meeting with CCBH
  - Attend meetings with funder, as needed
  - Assist program staff with preparing content for grant reports required by funder
- Monthly/Quarterly invoicing
