FLU & COVID-19 UPDATE

Brian Kimball, Interim Director, City of Cleveland

For Covid update, City of Cleveland current reported, 266 new cases, which is 69 new case per 100,000. This number may not be accurate, as it does not include unreported home tests. For the increase in 35% of new cases, Cleveland's average age was 60. We remind all that October is best time to get Covid boosters and flu shots and you can receive at the same time.

*Question: S. Harris - Are there cases of extreme sickness?

*Response: B. Kimball – No huge increases in hospitalization now, may be uptick in fall/winter months. For Moneypox, there were 143 cases in Cuyahoga County, 58 outside the City of Cleveland, and 95 in the City of Cleveland. From last month when there were 130 cases, the numbers have declined and reflect mostly males, majority black males that count for 98% or 133 of the total 143 cases.

*Question: A. Rollins - Are they figuring out the omicron variances?

*Response: B. Kimball – Yes, but there are multiple variants out and data has not been broken down.

Administrative Report – Z. Levar

- Statewide Integrated Plan (SIP) monthly update: The goals for the Affinity Group was drafted and will be shared with the wider group on Sept 29, 2022. Kate Shumate and her team are taking feedback through Oct 31st. If there are edits/suggestions, submit them before EOM, as the team plans to finalize things before the Nov 17th meeting.
- The Quarterly Case Manager's Meeting was yesterday where they group discussed sharing different resources and improving the referral process. There was a lot of good info shared and we will continue these conversations.
- Part A funding Currently all requests have been received from providers and we have now begun the reallocation cycle. This is where we look at mid-point spending and ask providers where they are across different categories, and then package this for recommendation to S&F committee before proposal to full PC in November.
- In September, we submitted the non-compete application to continue our funding. We have not received feedback, but should be good for the upcoming FY 2023 grant year.
- Two RFP's (request for funding proposals) released, for direct services and PC facilitator for 2023-24 grant year.

Fiscal Report – Z. Levar

FY2022 Part A Grant: Current Expenditure split - 78.68% Core - 21.32% Support, Expenses are at 45.87% for 6 months (50% target)

In October, we received invoices for September. For August through March, all invoices have been received, marking the six-month period in which we are on track in spending. A couple over-utilized services, oral health and med transportation, will be reviewed to see what changes occurred in these categories. With med transportation, it appears mostly due to present times with things now more expensive. As we do not want transportation to become a barrier, we are asking providers to use this much as possible, but we may look to S&F if we need to add.

- *Question: C. Droster Any idea of clients served in oral health?
- *Response: Z. Levar It was roughly 10-15 procedures, but we will provide better update at next meeting.
- *Comment: S. Harris As mentioned, transport may be due to more injection treatments, this may need review.
- *Question: C. Droster Why no dollar amount for home health care and home-based services?
- *Response: Z. Levar It's a contracting thing. We'll have to await full award before dollar amount can be given.

Medicaid Update - A. Thomas

- Cuyahoga County currently has just over 3,700 applications, being processed at a 80-82% timeliness rate.
- We were informed Monday that the Covid public health emergency will be extended through the remainder of the year, and we will await further updates into 2023.
- The next generation for Medicaid began Oct 1, 2022. The highlight is that all Medicare recipients will receive a new Medicaid card for whichever entity they choose, and they will all look similar.
- We are having a community partner conversation, tomorrow, Oct 20th and next Tuesday, Oct 25th. If interested, send an email and we'll connect you with the outreach team.

*Question: N. O'Neal - How long can a person be on straight Medicaid before getting assigned to an HMO?

*Response: A. Thomas – Through Covid emergency, we weren't able to continue Medicaid, but open enrollment now going on, so if they want to choose a new entity, they can reach out to Medicaid hotline: 1-800-324-8680.

*Comment: S. Harris - Thought selecting an HMO was an option not a requirement.

*Response: N. O'Neal - They want people to be with a provider not straight Medicaid.

*Comment: C. Nicholls – The County isn't involved with managed care, but that is correct on service plans. Now with open enrollment and changes in care plans, anyone who was new to Medicaid and would have gone to a managed care plan will not go on a plan until Dec 1st.

*Question: S. Harris - If they don't choose by open enrollment, will they be assigned?

*Response: C. Nicholls – Correct.

*Question: B. Glass - If a person didn't receive a new card, how to guide them?

*Response: C. Nicholls – Their Medicaid billing number will still work, but have them call Medicaid hotline number to make sure we have their correct address to receive information. The new card also has their pharmacy info, which is Gainwell, except for MyCare-Ohio and Fee-for-Service clients.

*Question: C. Barnett - With over 3,700 applications, what is the time range to get them processed?

*Response: A. Thomas – Forty-five days is considered timely and what we are afforded by the State.

*Question: J. Stevenson – Will the cards for Medicaid automatically be mailed?

*Response: A. Thomas - Yes, they will mail out, but make sure addresses are correct so they get to right locations.

Ryan White Part B Update – K. Ruiz

- Open enrollment Medicaid Part B, begins Nov 18th
- The Jail Workgroup met last month and went over what can be done. We now have a great opportunity to work with jails. If interested, the next meeting is tomorrow at 9:00.
- Syphilis numbers continue to rise so we encourage all to be tested.
- The Statewide Integrated Plan is on track and due out Dec 9th. All suggestions due by end of October, as goals will be shared with PC at the November 16th PC meeting and December 17th with the Statewide Integrated Plan group. We met last week and discussed trying to work with Strategy & Finance on ways to engage other consumers. We are also looking at education ideas, and we talked about having a jam session to express frustrations or needs of PLWH so we can bring this back to PC for input on how we can address.

Strategy & Finance (S&F) – C. Droster

In committee we discussed suggestions about having informative TV videos in waiting rooms as a way to reach out to PLWH, looking at ways to ensure social workers are more educated on RW services, we discussed housing services for aging PLWH, and reviewed the S&F and PSRA work plans.

Membership, Retention & Marketing (MRM) - B. Gayheart

We met Oct 5th and primarily reviewed new member orientation changes and updates and we went over the new member recruitment process. We also discussed having training for new co-chairs and agreed to have a special exec committee meeting on Nov 16th to focus on planning council co-chair roles and responsibilities.

Quality Improvement (QI) – J. McMinn

We met this afternoon with our first discussion on the deep dive into mental health and psychosocial services. The idea behind the dive is to come up with suggestions and creative ideas to deal with feelings of loneliness and isolation some experienced during the pandemic. In addition, we discussed looking into areas affecting the aging population and people experiencing trauma, with the goal to see what's needed, what HRSA will allow, and what we can refer to the recipient.

HIV Prevention (Prevention) – D. Houston

Our last meeting was last Sept 7, 2022. We received updates from Brandy on funding cycles and what RFP's were being released, a DIS (disease intervention specialist) update, and Epi (Ending the HIV Epidemic) staff changes and new director. The monkey pox percentage rates, which have stayed steady, went up only a little, and there was a long discussion on those most at risk, and making the vaccine more accessible to them. Also, Rebecca, from the Aids Task Force (ATF), spoke on numerous things and events they are doing to try and engage the youth. The next and last meeting of the year is, Wednesday, Dec 7, 2022 from 4-5:30 pm.
