## Prevention Program Update – Recipient Report – B. Eaton, M. Kolenz

**B. Eaton** - This year was to be last year for ODH funding cycle, but a decision was made to extend for another year. This is good, we didn't have to do a competitive application and expect to do one in later 2023. I've moved into role of Director of Nursing at CCBH, still overseeing STI, and looking to hire a person.

M. Kolenz – We are up a going with HIV and STI programs as we are in 100% positivity rates.

#### DIS Updates and Data Extractions from ODRS – B. Eaton

Clarence is now our CCBH new ODH Epidemiologist as Epi staff is now directed to monkeypox vaccine efforts. MKX, and we are still working to have that staff at next meeting. For DIS, we are hiring two new staff right now, as we have had a series of resignations and promotions while trying to maintain nine core DIS and one under EtHE. As a county with monkeypox, the finalized data is 97 cases in Cuyahoga, 50 in Cleveland, and the remaining 47 in the CCBH jurisdiction. About 97% are male, 2% female, and 2% not specified. As reported on the news, most cases are African American males. We started vax efforts in August, with the original plan to allocate vaccines to local providers who had relationships and could get them out quicker, then we allocated to some, and the rest went to the three major health systems. They had issues early on with getting walk-in patients. So, we've pivoted the approach to CCBH doing most of the vaccines. We had a decent uptick initially, but now weaning off. Preliminary data indicates that mostly 80% white men are getting vaccinated, but not the ones most affected in our case counts. We would like to talk strategies on reaching those with the most need in our jurisdiction.

**N. O'Neal** - This is different, maybe some are leery, coming behind Covid and asking to vaccinate.

**B. Eaton** - Agree, there is vaccine hesitancy from people of color across the board, Covid was initially.

F. Allan – Cleveland Dept. of Health is doing monkey pox vaccines.

N. O'Neal - Maybe incentives, like with Covid, they usually work.

**B. Eaton** - We have multiple emergency grants for Covid, possibly funds can divert to other responses.

**C. Barnett** – Maybe a stipend as a good idea will drive them to come out.

### Clifford Barnett, Deairius Houston – Co-chairs

**J. Patterson** – Make sure we have trusted providers not just hospital systems, maybe gatekeepers can give tickets or special passes to help get people in the mass clinics where they feel safe.

**B. Eaton** – Administering vaccines to non-patients are real challenges, as everyone wants to cover their costs. The vaccine is free but there is ability to recoup other costs.

**C. Barnett** – We want to ensure we have adequate promotion, just a flyer doesn't always work.

L. Cornell – Our med director offers PrEP and reached out to patients who may be interested.

**D. Houston** - Cleveland is more transactional than interactional. People want give and take, so we have to bring health care to them. Young African American men can't always get to places, so we have to be willing to have available staff at unconventional times and odd hours, rather than 9-5 only.

**C. Barnett -** There are not a lot of places for trans-people to go that are stable and continuous.

**S. Harris** - Costs is a factor for businesses, it would be helpful if the community had financial means.

**D.** Houston - If clients don't have insurance, we have to eat that and many fall under with insurance.

**N. O'Neal** – There may be an app for people to get insurance, as benefit specialists can help with presumptive insurance until their insurance comes through. Also, even if not eligible for Medicaid, marketplace offers tax credits, where one does not have to pay the full amount of insurance.

**D. Harris** - The Neighborhood Family Practice is offering the vaccine and it is going fairly well. We just completed a mass clinic last week. We reached out to HIV patients as well as additional "at risk" patients who have had an STD in the past year.

J. Patterson - Working to have MPV vaccine in all STD clinics would help.

**A. Rollins** - CDC has trainings available, Dr. Heckerman at MetroHealth has used one of them to present to Metro employees and others. CDC also has multiple one pagers available.

**R. Lewis** – Are there any available trainings offered for outreach workers to treat monkeypox?

**B. Eaton** – We have an outreach team to develop materials to explain monkeypox.

M. Kolenz - They did get a one-pager out so far, but not sure on trainings.

The youth also attended a CAVs and Monsters game and received job training a by Youth Unlimited. They also visited the Love Hate brand company that gives promotional materials and social media branding and learned about branding, selling and making clothes using Cricut machine designs. One item read, 'Don't get ghosted by Syphilis'. We also went to see the Christmas Story house,
