Mental Health & Psychosocial Service Category Review- J. McMinn

This brief slide presentation on the deep dive into the Mental Health and Psychosocial categories, covers the discussions that have taken place. We are now looking for feedback on next steps, such as if we want information on things like whether medical providers are providing screening, and ideas on what the aging population is experiencing so we can strengthen our TGA resources in that area.

*Comment: Dr. Gripshover - It's a requirement for medical professionals to do screening.

*Comment: S. Harris - We postponed Benjamin Rose presentation, as we <u>may need more research on what</u> <u>programs related to HRSA are out there in the local community, then focus on unique needs for aging PLWH</u>.

*Comment: N. O'Neal – We must <u>define isolation and discuss issues around that</u>, <u>discuss issues for those no</u> longer able to live alone, and look at different types of support groups.

*Comment: S. Harris - Getting people to take action is complex. Is the focus mental health, or other.

*Response: L. Yarbrough-Franklin – Yes, very complex, as most reveal this only once while in care.

*Comment: L. Yarbrough-Franklin - Maybe tap into Western Reserve on Aging or invite them to present.

*Comment: J. McMinn – Our TGA population is aging and we need to address the ability to have resources for this group. Maybe have a separate from mental plan that addresses our QI, TGA-wide aging population needs.

*Comment: S. Harris - As we try to bring an outcome to the deep dive, <u>products of the deep dive could include a fact sheet that encourages people to seek mental health support and a list support groups and other resources.</u>

*Comment: J. McMinn – Psychosocial tabled, as TGA does excellent job with mental health and many resources.

*Question: F. Ross - Do we have list of the support groups in TGA?

*Response: J. McMinn – Yes, not available to consumers, but could be as a directive to the recipient.

Next Steps – J. McMinn

Mental health now completed. We will next review Psychosocial and then move forward.
