Recipient Report – March 2023 – Planning Council

Administrative Update – M. Baker

- We received a partial award last month, as is standard practice, by March should receive full award.

- Moving forward w/providers in the RFP process, also acquired a new dental provider in Lorain County.
- We submitted the Integrated Plan, and is now in review.
- PC Facilitator RFP closed March 7th, still gathering responses, and selection will begin after March 7th.
- MCM to do streamlining of documentation, get ideas to provide services and make improvements.

- The Provider Kickoff is March $14^{\mbox{th}}$, where we get them acclimated on Part A

- The RW Provider Showcase meeting is March 23rd, where providers brief on RW services they provide.

- CQM (Case Quality Management) is currently working on projects, one looking at viral suppression connections between clients that are connected vs not connected to medical case management and those disparities. They are also meeting again March 29th to finalize and discuss upcoming projects. ***Question: J. Patterson -** Any others not awarded?

*Response: M. Baker – Far West, Fam Planning didn't re-submit, had small clienteles, don't see gaps.

*Question: R. Watkins - Where is funding to train outreach front-liners for rapid testing?

***Response:** N. O'Neal – Years ago, The Centers/ Circle Health was able to provide some training because they also were training volunteers, but not sure if this is still true.

New/Old Business

Cleveland Department of Health – HOPWA Presentation – J. Citerman-Kraeger

- HOPWA History - Created in the AIDS Housing Opportunities Act, a part of the Cranston-Gonzales National Affordable Housing Act of 1990, to provide housing assistance and related supportive services for low income people living with HIV/AIDS, and their families.

- The HOPWA program is a homelessness prevention program designed to provide housing assistance and related supportive services for low income people living with HIV/AIDS and their families.

- HOPWA is a formula grantee program, having two types of grants made under the program. HOPWA formula grants are made using a statutorily-mandated formula to allocate approximately 90 percent of HOPWA funds to eligible cities on behalf of their metropolitan areas and to eligible States. HOPWA competitive funds are awarded on the basis of a national competition.

-In 2016, the HOTMA (Housing Opportunity through Modernization Act) was established. This is a rebalance how funding was distributed across the country.

- The grant covers the Cleveland Metropolitan Statistical Area (MSA) which includes: Cuyahoga, Geauga, Lake, Lorain and Medina Counties, and is funded by HUD to the City of Cleveland.

- HOPWA provides a variety of services such as, rental assistance, housing placement, workforce development, daily living assistance, and meals/nutrition services.

- Programs Partners include: AIDS Taskforce of Greater Cleveland, EDEN (Emerald Development & Economic Network Inc.), Northeast Ohio Coalition for the Homeless (NEOCH), Nueva Luz (NLRUC), and Joseph's Home (JOE HM).

*Comment: J. Patterson – Hearing PLWH housing needs and seeing HOPWA is main provide, would like more info on slide talking of other services and that funding.

***Response:** J. Citerman-Kraeger - These support services have always been in the RFP. We know all RW doesn't cover all needs, but doubt if agencies will apply although they are available. Having asked about childcare on how much can be appropriated, reply was an agencies, if wanted, could apply to provide that service though, technically, RW and HOPWA are payers of last resort. This is something we need to let people know is available, can be accessed, but has never been done locally.

*Question: J. Patterson - Can we offer something to make that a deliberate thing?

*Response: J. Citerman-Kraeger - It can possibly come from co-chairs, when deliberating on RFP's,

asking if they could consider not funding categories and RW will take care of that.

*Question: N. O'Neal - On housing research placement, what is that?

*Response: J. Citerman-Kraeger - CM that provides assistance on where housing is available.

*Comment: N. O'Neal – As told, clients have to find a place then come back to case managers with update, then they do next steps, otherwise no help in finding housing.

*Response: J. Citerman-Kraeger - Will research CM part in RW, as is now monitored with low emphasis.

*Question: N. O'Neal - How can you verify patients received assistance? What questions will be asked? *Response: J. Citerman-Kraeger - Questions on HUD website will include reviewing files, also want to know how much CM is doing to assist clients, the research they provide, and how they assist with finding housing.
