Listening Session Planning

Continued Planning of the Listening Session - N. O'Neal

The flyer looks really nice and the QR code is a good idea. Perhaps we should provide the link, as well. Copies of the flyer were brought to the Transforming Care conference today, hoping PLWH will pick them up social workers in the field who may be attending. One question of concern is if we only want people from Cuyahoga County who we serve to attend the sessions, or are all counties invited to join, as it was thought the idea was to promote not just in our six counties, but also for any RW eligible persons living with HIV, who might be asking these questions, whether in our communities or not.

- *Comment/Response: L.J. Sylvia For the flyer QI info or other tech help, people can all or text me, if needed. As for other counties, we should try to focus on the population of the counties we serve, considering the small turnout for the last session.
- *Comment/Response: T. Marbury The flyer is tastefully done, like the diversity. If people are asking about RW services which they may not have in their county, this gives them an opportunity to fight or advocate for something. But if it's just for our county, the flyer should indicate that it's for Cuyahoga.
- *Comment: N. O'Neal For now, the sessions are just for listening to issues of PLWH, not offering advice, so how or do we focus on sessions with other folks, counties, etc.?
- *Response: L.J. Sylvia It may help to circle back and look at how the sessions were designed which was to: listen to the community, express concerns, meet the community, promote self-advocacy, as well as participation in CLC.
- *Comment: T. Marbury- We should be clear that we can't serve outside of our community. That would alleviate the issue of people coming in from other areas.
- *Question: J. Mazo Is there some way we could gather data for folks outside our TGA?

- *Response: L.J. Sylvia Great point. We will add all our counties to flyer, and if someone shows up from a separate county, we will clarify the intended audience, give folks a choice on whether to stay, and make side notes to follow-up. More importantly, we will try to connect them with folks in their counties.
- *Comment: M. Baker- We serve other than Cuyahoga, so we shouldn't look only to focus on Cuyahoga.
- *Comment: L.J. Sylvia The flyer will be wrapped up tomorrow, but if you have one, you can share that.
- *Question: P. Scardino Who is getting the flyer and are we broadcasting to the community?
- *Response: N. O'Neal- Once everyone gets flyer, it's our responsibility as CLC to send it out to our communities, social workers, PLWH that you know, ASO's (AIDS Service Organizations) in the county, FB, Twitter, and almost anywhere to get them involved
- *Response: L.J. Sylvia We also agreed to do this broadly to all and will send personalized invites to contacts, friends, and support groups.
- *Comment: P. Scardino In this county, we have to rely on social workers, as there is not much contact with PLWH in Ashtabula. Signature Health and Community Counseling in Ashtabula deal with PLWH, so maybe they would distribute to people they work with or know. Will reach out to all case managers with my clients at Signature, and Matt Butler at Community Counseling.
- *Comment: L.J. Sylvia On workgroup Tuesday, Oct 10th, we will gather more input on the listening session agenda, as it seems there is more info upfront offered, instead of listening. Maybe we can think on topics for listening and on what we want to give them.
- *Question: R. Watkins- Will we consider an interpreter?
- *Response: L.J. Sylvia We can look at that if needed.
- *Comment: P. Scardino We also don't want to assume everyone knows about RW, so we should ask basic questions, like do you know about the RW program?
- *Comment: N. O'Neal We can also inform what service RW offers, give background on RW, and ask if they know who is eligible for RW services?
- *Comment: L.J. Sylvia Maybe broadening that question to what has been your experience been in accessing RW services.
- *Comment: R. Watkins— Also, what are your barriers to getting health care, and while there are barriers to obtaining health care, we still have to educate first.
- *Comment: N. O'Neal We also want to make aware that RW is a payer of last resort.
- *Comment: L.J. Sylvia We can dive more in the workgroup, but for now, it seems there are more questions around educating, versus listening. The other issue is on barriers that impact their experiences to access services, or generally speaking? Looking at PSRA for next year, we want to listen so we can get the data we need on what's most important to people. We can also do polling in the Zoom meeting to see what people want.
- *Comment: B. Gayheart Good input, ready to get this going.
- *Comment: J. Mazo If involved in a listening sessions, my purpose would be on things I'm experiencing issues with, such as difficulty in appointments especially with more PLWH aging. The concern is hospital systems working towards more availability for appointments for various health challenges.
- *Comment: B. Gayheart We must also be mindful of the limited time, and to use that time to hear what people have to say.
- *Comment: N. O'Neal The in-person session should be different, maybe we should also discuss how this should go?
- *Response: L.J. Sylvia The purpose, intention, and guidance, are the same for both. We will talk more in the workgroup on what will happen, and look at how we want the environment to be so people can engage, particularly for the in-person session at Neighborhood Connections. This event will be more
