CLC Survey Update

N. O'Neal - The surveys have surpassed what was expected, as last heard there were 132 which means we are getting the word out more and people are participating more.

F. Ross - It was actually 132 in English and five in Spanish.

N. O'Neal – This means we should do both, so people can have them in their own language.

L.J. Sylvia – To date, there are 137 English and five in Spanish. Also, for those doing paper surveys, please make sure to review them first so we can enter the data accurately as possible., and please encourage all of your contacts to get in their surveys.

Review Listening Session Data to Prepare Presentation for S&F - L.J. Sylvia

We will now review the past listening sessions to get feedback on making changes and/or on improving them on how we want them to look in the future, as these listening sessions will add value to the CLC survey in providing key data needed for PSRA ranking and prioritizing of Part A services.

The Community Liaison Committee (CLC) hosted three listening sessions in 2023, as a way to better hear from people living with HIV (PLWH), to discuss their health care needs, as well as provide information about resources available to them.

- The committee hosted one (1) in-person, one online, and an impromptu session at a women's retreat.
- Eleven (11) participants at the in-person session
- Nine (9) participants in the online session
- Twenty-two (22) participants at the Women's retreat

Question #1: As a person living with HIV, what makes it easier for you to stay healthy? Responses

- Medical case manager "They check in on me, remind me of appointments, and educate me."
- Support from family members and trusted friends
- Finding safe spaces "Spaces where people accept me no matter who I am."
- Connections to other PLWH Peer support, a way to stay updated, informed and educated
- Staying on track with medication "Shots make it easier for me", "Getting into a routine."
- Strong relationships with doctors, nurses, and the care team
- Access to care Being insured, and the ability to get care through the VA or outside that system

Question #2: What makes it easier or better for you to get services and stay in care?

Responses

- Help navigating the system
- Support groups
- Case workers
- Access to services
- Sobriety & prioritizing myself
- Dental services
- Other professionals who work with doctors nurses, non-medical case managers, peer navigators

Queston#3: What challenges do you face as a person living with HIV?

Responses

- Housing This was echoed by many and identified as the biggest barriers.
- Stigma:

Not being noticed

Acceptance in relationships-family, friends, and partners

Stereotypes

Stigma in medical community- "Finding out you have HIV, tie that to everything else."

Finding specialists who will treat me as a person

- Difficulty finding a primary care doctor This was especially an issue for people who are older and have multiple medical conditions. Stigma makes it especially difficult to find a primary care doctor who can effectively support patients who have HIV. They need to be willing to accept PLWH and then collaborate with specialists.
- Also difficulty finding an LGBTQ-friendly primary care provider

Question#4: What challenges to you face as a person living with HIV?

Responses

- Intimate Relationships "Even with U=U, difficult to find someone on same wave length not biased."
- Lack of transportation is a barrier It can be difficult getting bus tickets.
- Lack of information and education about Ryan White services

Not getting accurate info about eligible services, you have to know what to ask to get info.

Difficult to know eligible RW services available to you, if you have insurance

- Access to care and support in outer counties

"Lake County is a Ryan White desert and stigma is greater."

Difficult getting counseling when working and having income

- "Being in the VA system, is sometimes difficult to get care needed. Had to go outside the system to get Mpox vaccine, it is difficult to navigate other systems."
- "As a PLWH, having served on boards and worked for an ASO, it can be difficult to wear many different hats and focus on myself."

- **S. Washington** <u>- Metro is opening up an outreach</u> at 2200 MetroHealth Drive, Villa Sana apartments. Last meeting, two vans came, gave a testimony and gave out info. <u>Maybe they have space to do some in-person connecting</u>. Mary Lee Santiago is a contact.
- **L.J. Sylvia** We have a <u>PC member feedback form out, we are working on a new application as we want to recruit more youth, 30 and under, and we are also looking to create an in-person orientation which will include a meal.</u>
- **B. Gayheart** This would be a great opportunity as there are still members some have never met in person, and just a great way to finally see each other, face to face.
- **N.** O'Neal Maybe Prevention can go to opposite events than those we attend to do testing, community outreach, etc.
- **L.J. Sylvia** We would like to see overlaps and how PC and Prevention can work together, so all doesn't fall solely on PC. Also recommend Neighborhood Connections, as they do great events and provide grant funding, as well as space for events and organizing in community-building.
- **F. Ross** For the college events mentioned, are there any in particular?
- **B.** Gayheart White at Task Force few days ago for discussions on trans issues going on in Ohio, they brought up <u>Case Western</u>, <u>LGBTQ Center</u>, and <u>Oberlin</u> as places and colleges that might have spaces for <u>connecting with folks</u>.

For church health fairs, however, they have all kinds of events but we must tread lightly so as to be respectful of their practices. Also, perhaps we can coordinate with Prevention to do testing at a health fair, or people can look at grant opportunities to help sponsor events and/or offer incentives, as a way to bait people. Also, agree with looking at a zip codes, asking those areas if we can offer testing, info, condoms, etc. Last, as CLC members, we'd like all to be involved in these efforts because we need everybody.
