- Prepare for your visit
- **Verify demographics**, insurance information, pre-pay, keep your medication list up-to-date, as well as update your allergies all before you arrive. Learn more.
- Access your test results
- No more waiting for a phone call or letter. View your results and your doctor's comments within days.
- Communicate with your doctor
- Get answers to medical questions without phone tag or unnecessary appointments.

**J. Silva** – In summary, MyChart gives online access to your medical record and provides a digital version of your medical record in office. My Chart Features: Provides steps to prepare for visits, verifies demographics, eliminates wait time for phone calls or letters, gives access to test results, communicates with doctors, and provides answers to medical questions. You can also use it for multiple MyChart providers you may have by just setting up one account for all of them, as there is no need for separate accounts. Bottom line, MyChart is most beneficial in that it allows you to navigate your own health chart, and it eliminates excessive phone calls to providers for requests on basic updates and information.

#### Q&A's

- \*Question: N. O'Neal Is it legal to give HIV results in MyChart?
- \*Response: J. Silva- Yes, because it's your medical record and only you have access to your chart.
- \*Question: N. O'Neal Could that affect a newly diagnosed person who may not be having support in real-time?
- \*Response: J. Silva MyChart is not a shared account and does not violate HIPPA (Health Insurance Portability and Accountability Act), because it only goes to you. However, as that may become an issue, we will follow up on this.
- \*Question: C. Droster Can MyChart be shared with family if they're allowed access?
- \*Response: J. Silva Yes, it can be shared with family, but you must allow them access. Also, if you have difficulties accessing MyChart, you can always reach out to our digital navigator to help, as well as to set up a time to assist you if needed.
- \*Comment: N. O'Neal In the past, appointments have been made on MyChart, only to find out later there was no appointment.
- \*Response: J. Silva Sometimes if old appointments haven't cleared out, new ones may not show up. Also, some clinics don't allow registering by phone, only in-person.
- \*Question: K. Dennis In using MyChart with different hospitals, it usually involves logging onto CCF for some info, then MH for more, but for UH no info is given. Can we access one site to get all the info?
- \*Response: J. Silva It may be that CCF was left as the primary provider, in which you may have to go into the actual MyChart website and register through the UH portal.
- \*Question: L.J. Sylvia What about virtual visits, how do you get info in there?
- \*Response: J. Silva That would require MyChart log in capabilities, as the reason most mergers happen is because all those facilities use the EPIC system. However, for those who don't use EPIC, like the V.A., MyChart wouldn't be readily available.
- \*Comment: N. O'Neal It's also annoying to list meds at every appointment, as it's in the chart.
- \*Response: J. Silva- It's more to verify the meds you're taking, than that they're on your chart.
- \*Comment: C. Droster We need patience going to the doctor. They ask the same questions but are just doing their job.

- **N. O'Neal** We went to the first Pride event for Cleveland, had eleven surveys completed, as our goal then and now is not to be stressful, but to just engage without thinking about having to have surveys done. Also, thanks to CCBH in sharing one of their two tables with us, and we encourage other people to participate in these events, in which some will be much smaller than Cleveland, where you can ease you into this more comfortably.
- **F. Ross** Billy had seven and four were collected from me.
- **L.J. Sylvia** We also had a flyer for the upcoming August CLC meeting, which will have a presentation by Dr. George Yendewa, on cardiac research supporting PLWH. So, the more that come to CLC, the more people can connect on issues relevant to PLWH.
