New/Old Business

Prioritize Remaining Funded Categories – Core Services

Service Categories Are Ranked

As part of the PSRA (Priority Setting & Resources Allocation), all service categories must be ranked.

Before the June PSRA meeting, the Strategy & Finance (S&F) Committee leads the ranking process during

Strategy & Finance Committee meetings.

The final ranking is voted on by the full Planning Council at the June PSRA meeting.

The Criteria for Ranking

Payer of Last Resort - Are there other funded sources that provide the same or equivalent service to Ryan White eligibility accessed or maintenance in care?

Rank: 8= no other sources; 5 = few sources; 3= sufficient sources; 1 = numerous sources

Access/Maintenance in Care - Does the category promote access OR maintenance in primary medical care? **Rank:** 8 = fully promotes access & maintenance in care; 5 = mostly; 3 = somewhat; 1 = does not

Specific Gaps/Emerging Needs – To what extent do Part A-funded services address a specific service gap or service need? Does this service address a newly identified or projected future need?

Rank: 8 = highest need or gap; 5 = moderate need or gap; 3 = low need or gap; 1 = no need or gap

Consumer Priority – Has the category been specifically identified as a priority by PLWHA through needs assessment data and/or other data as important and/or in need of additional funding?

Rank: 8 = highest priority; 5 = priority; 3 = somewhat a priority; 1 = not a priority

J. Patterson – As a reminder on managing conflicts before voting, please let us know if you are conflicted in the chat. If you are conflicted, add the name of the organization you represent and the categories where you are conflicted in the chat. This is important, as if you are conflicted you cannot advocate for or against a certain category. For each category, we will use the data we have to prioritize them, and will hopefully cover the eight core categories. Also, for Payer of Last Resort, we are looking in that if people are eligible to use RW Part A services, likely they are ineligible to use other services, so as a last resort they are using Part A.

Finalize Decision About Which Categories to "Flag" for June 26th

For PSRA meeting on the 26th, we will be looking to get final approval from planning council on the service categories that were prioritized in the Strategy & Finance (S&F) May and June committee meetings. We then will look at items that have been "flagged" (brought to attention) in our workgroup for further discussion. As there is an overall budget, we cannot add or subtract from that, but we can move things around, keeping in mind the split (how the money is divided), in which 75% of the allocation must go to core services and the other 25% to support services. Also, we are not obligated to change things in these allocations, but we are more so to look at things that may have changed, how funds were expended, and trends in utilization, as we begin our discussions on items that may need further review. Overall, we want to show how what we will present, relates to how things ended up in the "PS" or Priority Setting process, and bring this to the PSRA discussion.

Flagged Items for Discussion at PSRA

- 1. The goal is to have NO MORE than five (5) service categories for discussion for PSRA.
- 2. The Resources Allocation work group identified the categories for flagging (listed below).
- 3. One June 5th, we will finish Priority Setting, then try to eliminate some of the categories from this list.

Psychosocial Support
Other Professional Services (Legal)
Non-Medical Case Management
Early Intervention Services (Outreach)
Mental Health Care Services

C. Droster – This was done in our workgroup, and we'd like members to decide two categories for PSRA. **Julie** – We agreed as a group on the five, but not to get stuck on an exact number we can decide now. Also, for FTE (full time employ), this means the service is primarily used to pay for staff, or to pay people who work in a service category, as opposed to a deliverable service.

Jason – If not a clear decision on two, we are not obligated to flag anything, but we can report back on what we want to do, as we decided this process on our own.

Clinton – Flagging is about us looking into the future on trends, if we're losing or increasing money, so as to adjust things and stay ahead of trends.

Lj – We can table flagging items for the pending S&F workgroup tomorrow, to make sure all parts are covered for PSRA.

Julie – We will table this until tomorrow's workgroup meeting at 3:00 pm., and look at the agenda for PSRA.
