Recipient Report May 2024 - Fiscal Report Review - M. Baker

This is our final report for the 2022-23 grant year. We are at 79.643% for core services, 23.37% for support, and the expenditures have been utilized well and are in good standing. We are also still looking at options in providing better and more clear report presentations.

*Comment: L.J. Sylvia – The main issue we want to remember is not to exceed our support services. HRSA requires us to keep Core Services at 75% or more. Support Services must be 25% or less.

*Comment: M. Baker -We are not in jeopardy in what is being presented at this time. However, it is important we use the best strategies in following the HRSA guidelines for the majority of funding to go to core services, and not allow support services to creep into the core services pot.

*Comment: C. Droster - The 95% number for YTD Spending is also important because if it's less, it means we didn't spend enough, whereas if it's more, we can ask for additional money from HRSA for the next grant year.

Ryan White Part A Expenditures Summary May 2024 - M. Baker

As an overview, 95.68% of the budget for this grant year has been utilized, the target for this timeframe is 100%, and we will make a request for carryover for the remainder of the budget. Looking ahead, items of local concern on the horizon include: aging with HIV/AIDS, being inclusive of Black Women in HIV prevention, treatment, and data gathering/sharing, and housing concerns for PLWH.

Prioritize Funded Categories – Core Services

Service Categories Are Ranked

As part of the PSRA (Priority Setting & Resources Allocation), all service categories must be ranked.

Before the June PSRA meeting, the Strategy & Finance (S&F) Committee leads the ranking process during

Strategy & Finance Committee meetings.

The final ranking is voted on by the full Planning Council at the June PSRA meeting.

The Criteria for Ranking

Payer of Last Resort - Are there other funded sources that provide the same or equivalent service to Ryan White eligibility accessed or maintenance in care?

Rank: 8= no other sources; 5 = few sources; 3= sufficient sources; 1 = numerous sources

Access/Maintenance in Care - Does the category promote access OR maintenance in primary medical care? **Rank:** 8 = fully promotes access & maintenance in care; 5 = mostly; 3 = somewhat; 1 = does not

Specific Gaps/Emerging Needs – To what extent do Part A-funded services address a specific service gap or service need? Does this service address a newly identified or projected future need?

Rank: 8 = highest need or gap; 5 = moderate need or gap; 3 = low need or gap; 1 = no need or gap

Consumer Priority – Has the category been specifically identified as a priority by PLWHA through needs assessment data and/or other data as important and/or in need of additional funding?

Rank: 8 = highest priority; 5 = priority; 3 = somewhat a priority; 1 = not a priority

- **L.J. Sylvia** As a reminder on managing conflicts before voting, please let us know if you are conflicted in the chat. If you are conflicted, add the name of the organization you represent and the categories where you are conflicted in the chat. This is important, as if you are conflicted you cannot advocate for or against a certain category.
- **J. Patterson** For each category, we will use the data we have to prioritize them, and will hopefully cover the eight core categories.

L.J. Sylvia – Also, when getting the total for rank score, multiple services may have same number and if so, we use the unduplicated clients to break that tie.

J. Patterson - For Payer of last resort, we are looking in that if people are eligible to use RW Part A services, likely they are ineligible to use other services, so as a last resort they are using Part A.
