### Discuss the Launch of the Working Group for Youth Engagement - B. Gayheart

As this has been a long-time passion, we recently reached out to several people who have agreed to be part of a new youth work group. This is to be a separate group designed for young people to take the reins and lead in conversations on things that concern them. We are looking to begin these brainstorming discussions starting in November then in January, February, and March, for the second Wednesday of each month. As throughout the years there has been a lack of youth involved in PC, we want to see how to better engage them to be involved and participate, rather than just attending meetings. This would be a starting point in making something happen and to see what may come about from this.

- **L.J. Sylvia** The data shows we are getting older and need to do better job of recruiting youth, and having them coming to listening sessions around engagement.
- **C. Brady** Being just a year into PC, happy to join and to be part of helping younger people know what's going on with PC and HIV care, in general. As it's often hard to have support systems early in life, this would help bring younger people together and help them, in this space, find common ground in the community.
- L.J. Sylvia To confirm, the group timeline is four months: November, January, February, and March.
- **B. Gayheart** What are suggestions for times/hours for the workgroups?
- **C.** Brady Perhaps 12-3:30 pm, and/or maybe an evening slot, as in reaching out to folks on the group who were already active, most feedback was on the timing.
- N. O'Neal We should have those running the group to speak on what time and day. Also, as older members may not be the best way to go, maybe we should reconsider this for now.
- B. Gayheart It has been difficult trying to start this, as only a few young people have responded.
- J. Mazo We have already run into a hurdle, except for one. As a former educator, unless something is led by youth, they often won't buy into this. So, how can we change the landscape on this today?
- **L.J. Sylvia** In organizing we say, whoever shows up, are the right people. Looking at that, we want to ask are you willing and able to serve, identify those would will serve, and if only a few show up, those are the right people. The questions then, is how to get the rest of the people?
- C. Brady A form was created that anyone can fill it out and put in comments. This could also be a mixed-methods approach with meetings, group chats, social media campaigns, etc., having something people can do on their own time outside of a structured meeting. We can also come up with marketing materials on what PC is and why it needs youth.
