Thrive for Change- \$50,000 Nueva Luz Urban Resource Center- \$50,000

Brief Justification:

Thrive for Change had the highested score from the review committee. Thrive for Change propsed engaging 300+ individuals in high-incidence neighborhoods and reaching 150 through direct HIV testing by May 2025; and aim to reduce transmission rates and enhance health equity for vulnerable communities. The project aligns with the Cuyahoga County Ending the HIV Epidemic Plan, targeting high-risk populations like people who use drugs, MSM, and MSM of Color, through culturally sensitive, relationship-based outreach.

NLURC had the second highest score from the review committee. NLURC will provide comprehensive Reproductive and Sexual health education, all in relation to how to prevent the spread of HIV. In addition, NLURC will offer free and confidential HIV screenings at events, community agencies, and in the NLURC office. NLURC will also be responsible for planning and executing outreach events to raise awareness of EHE and reduce the spread of the virus through testing and prevention education. From January 2025- May 2025, NLURC's goal is to test 75 individuals for HIV and to provide HIV prevention education and outreach to 100 individuals
