<u>CUYAHOGA COUNTY BOARD OF HEALTH</u> <u>MINUTES OF THE MEETING – FEBRUARY 14, 2025</u>

Meeting called to order by Dr. Gregory Hall, President of the Board at 9:03 a.m. in the office of the Board, 5550 Venture Drive, Parma, Ohio, on February 14, 2025.

The following members were present: Dr. Gregory L. Hall, Mr. Douglas Wang, Ms. Sonja Rajki, Dr. Sherrie Williams, and Mr. Daniel Richards.

The Secretary called the roll: Ayes: Dr. Hall, Mr. Wang, Ms. Rajki, Dr. Williams

It was moved by Dr. Hall, seconded by Mr. Wang, that the following Motion be adopted:

BE IT RESOLVED to excuse Mr. Daniel Richards due to a schedule conflicts at the time of the meeting. Ayes: All, Nays: None – motion carried.

Public and Staff Comments (maximum 3 minutes)

Julie Patterson, Director of the AIDS Funding Collaborative and member of the Cuyahoga Regional HIV Prevention and Care Planning Council where they serve as one of the co-chairs of the Strategy and Finance Committee.

Julie Patterson presented context about the Ryan White HIV/AIDS Part A Program's HIV services here in the Transitional Grant Area, about other HIV-related services funded here at CCBH through the CDC and the Ending the HIV Epidemic Initiative (EHE) and to offer support for ending the temporary hold on reimbursements to sub-grantees of the CCBH. Legislative Updates

General Counsel John Mills presented his review of the landscape of current Executive Orders and pending lawsuits with regard to the federal funding freeze. Ms. Wirsching stated that our funders are still honoring our payment requests with no intention of changing that at this present time. Mr. Mills stated that the Cuyahoga County Board of Health will proceed cautiously with spending and hiring of grant funded positions. Ms. Wirsching presented to the Board the percentage breakdown of positions which are whole or partially grant funded.

Dr. Hall thanked Mr. Sobolewski for his service as Interim Director of Environmental Public Health, and congratulated Mr. Johnson on his promotion to Director of Environmental Public Health.

Approval of Resolutions/Motions:

Kevin Brennan presented Resolution 2025-002, stating the need to improve efficiency in in the design and production of materials related to promoting awareness and prevention of disease and illness.

Melissa Kolenz presented Resolution 2025-004, for a syphilis prevention campaign that will run in the six county service area which also includes Spanish translation services for the ads.

Erin Lark-Turcoliveri presented Resolution 2025-006, which will advertise the "Love Leads Here" HIV awareness campaign on the court and concourses during local NBA Cleveland Cavaliers basketball games. Ms. Lark-Turcoliveri also mentioned the Cuyahoga County Board of Health will onsite at the games tabling and distributing HIV test kits.

It was moved by Mr. Wang, seconded by Ms. Rajki, that the following RESOLUTION 2025-006 be adopted:

BE IT RESOLVED to Authorize the Health Commissioner to enter into and execute a contracts with the Cavaliers Operating Company, LLC & Rock Entertainment Sports Network, LLC under the 2024/2025 Ending HIV Epidemic-Care grant from January 29, 2025 through June 30, 2025 in the amount not to exceed \$66,500.00.
