This level of review is not required by HRSA and would make it difficult to meet the deadlines due to HRSA for the Corrective Action Plan. Sample revised language: "The Executive Committee is responsible for developing, reviewing, and making any needed amendments to the Bylaws. Where necessary to ensure compliance with all relevant laws, the revised bylaws will undergo legal sufficiency review by the legal representative of the Cuyahoga County Executive or his/her designee. Revised bylaws may also be submitted, where necessary, to the HRSA/HAB Project Officer for review to ensure that they meet Ryan White legislative requirements and HRSA/HAB policies." | | | | |
